Up To 2 Year Component Guarantee

If defect(s) are found in materials, workmanship, or assembly **before** the product has been run or started then HPI will exchange the entire product provided is returned complete in good condition and in its original packaging. Once the product has been used only a component level guarantee is available and HPI will gladly repair or replace the defective component(s) at our discretion.

Due to the complex nature of HPI Products and legal requirements of different regions, guarantees issued by HPI are only valid for products sold to and purchased in their respective regions and are not transferable to other parts of the world. Your guarantee is provided in addition to and does not affect your local consumer rights.
